Decision of the Panel – Chief Commissaire Anne Cobban:

Milford ITT (June 6th)

The commissaires noted that many bicycles at the time trial did not meet the technical specifications requirements, and in some cases could not be adjusted to be compliant. It is strongly suggested that riders review the relevant bike measurement rules 1.3.011 through 1.3.025.

Further details will be forthcoming in a communiqué regarding time trial bike measurements.

Please be sure to pick up your bottles after your race. Littering infractions are subject to fines of up to \$30 per instance.
